6Secretariat

The total staff strength of the Rajya Sabha Secretariat during the year remained at 1016, out of which 274 persons were holding group All posts. There was no retirement on superannuation in the Secretariat during the year.

The budget estimates of the Secretariat during the year 1998-99 were kept at rupees 38 crores and 15 lakhs.

The Distribution Section of the Secretariat received 8642 communications and worked throughout the year, even on Sundays and holidays. The total dispatches made by the Section during the year came to 168993.

The translation work of the Secretariat was undertaken by the Editorial and Translation Service. The work of the Service involved editing of debates, preparation of indices to debates, providing translation of papers and documents including lists of business, questions lists, etc. In order to promote the use of Hindi in the Secretariat, the Raj Bhasha Prabhag was created in the year 1997 which was quite active during the year 1998.

The Printing and Publications Service handled a large volume of printing work which emanated from the Secretariat. The total number of pages got printed during the year by this Service came to 49117 pages.

A brief description of the mandate of the Secretary-General, Joint Secretaries, Directors and Deputy Secretaries incharge of different divisions/services is given in the accompanying Table.

4 New initiatives



A Computer Cell was set up in the Rajya Sabha Secretariat in December 1997. During the year, this Cell was instrumental in purchasing 170 computers and the same number of printers for use of Members. The Cell also purchased 74 computers and 65 printers for use in the Secretariat. During the year, Rajya Sabha web page was created and the following items were put into it:

Committees I mini legislatures

A view of the Committee Room Parliamentary work is transacted not in the House alone. A great deal of it is done in the committees as well. Parliamentary committees are, in fact, mini legislatures. There are at present 12 Standing Committees, members of which are nominated by the Chairman of Rajya Sabha. There are 17 Department-related Parliamentary Standing Committees each of which has 45 members 1 30 from Lok Sabha and 15 from Rajya Sabha. Out of these 17 Department-related Parliamentary Standing Committees, 6 function under the direction and control of the Chairman of Rajya Sabha. Parliament and the people



There are two Reception Offices located in the Parliament House complex – one near the Parliament House and the other at the Parliament House Annexe. These Reception Offices help visitors to meet Members of Parliament, Ministers and officers of Rajya Sabha and the Rajya Sabha Secretariat. The Reception Offices also issue entry passes to the officials of the Government Ministries and Departments coming to Parliament House and Parliament House Annexe in connection with their official work. In the entire year, the two Reception Offices issued 31293 casual entry permits and 195 interview slips.

During the year, 114 general passes, 20 library passes, 1065 Central Hall passes, 114 DVG (diplomatic) annual cards and 626 DVG (diplomatic) daily cards were issued. Also, 6059 Official Gallery passes and 2913 general passes to witness the sessions of Rajya Sabha were issued. Nearly 20630 persons including VIPs, Press Correspondents, officials from various Ministries and Government Departments and the members of the public witnessed the sessions of Rajya Sabha. On the recommendations of Members of Parliament, 1973 visitors were shown round the Parliament House by the Watch and Ward staff.

As in the past, recorded proceedings of the Question Hour in Rajya Sabha and Lok Sabha were broadcast on AIR during alternate weeks. Assistance was provided to Doordarshan for the live telecast of proceedings of Rajya Sabha.

A proposal received from M/s. ECIL for upgradation of CATV System in Rajya Sabha sector was agreed. The material concerning upgradation was supplied by M/s. ECIL. The project involved additional cabling both in Parliament House and Annexe. The cabling was done by CPWD. The upgradation would provide addition of more channels. The upgradation of the system was completed in Parliament House and was in progress in Parliament House Annexe. During the year, 12 new colour T.V. sets have been installed in various rooms of Rajya Sabha sector to see the live proceedings of the House.

During the year 1998, Rajya Sabha sat for 6 days in the 183rd session, 35 days in the 184th session and 18 days in the 185th session. The 184th session was divided into two spells. The first spell was between 27 May and 12 June and the second spell was between 3 July and 4 August. The House sat for longer than the normal 5 hours on 43 days and without lunch break on 5 days.

Rajya Sabha Chamber

Summons for the 183rd session of Rajya Sabha was issued on 21 March. The session that commenced on 25 March adjourned *sine die* on 2 April. The interim budget session of Rajya Sabha commenced with an address by the President to the Members of both Houses of Parliament assembled together in the Central Hall on 25 March. Summons for the 184th session was issued on 29 April. The session commenced on 27 May and was adjourned *sine-die* on 4 August. Summons for the 185th session was issued on 20 October. The session commenced on 30 November and adjourned *sine die* on 23 December.

During the year under review 115 lists of business were issued with regard to the business of the House. In all 4658 papers were laid on the Table of the House. During the year 5 divisions were held. The total reporting work in respect of the sittings of the House came to 368 hours and 24 minutes. The various Parliamentary Committees including the Department-related Parliamentary Standing Committees accounted for a total of 271 hours and 38 minutes of reporting work. At present arrangement exists for simultaneous interpretation into English/Hindi of the speeches made in Hindi, Urdu, English, Assamese, Bengali, Gujarati, Kannada, Malayalam, Marathi, Oriya, Tamil and Telugu. The facility of interpretation from these languages is also available during the Ouestion Hour. Besides, simultaneous interpretation facilities were provided for the 145 meetings of the Department-related Parliamentary Standing Committees and other Committees. The average attendance of members during the 183rd session came to 181. It was 174 during the

184th session and 175 during the 185th session. The highest attendance on a day during the 183rd session was 198. It was 205 during the 184th session and 196 during the 185th session.

Consequent on the expiration of the term of office, Dr. (Smt.) Najma Heptulla ceased to be the Deputy Chairman of Rajya Sabha with effect from 4 July. Accordingly, the office of the Deputy Chairman fell vacant. The election to fill the vacancy was held on 9 July. The first motion moved by Dr. Manmohan Singh and seconded by Shri Pranab Mukherjeefor the election of Dr. (Smt.) Najma Heptulla as Deputy Chairman of Rajya Sabha was put to the House and the Motion was adopted. The Chairman declared that Dr.(Smt.) Najma Heptulla had been chosen as the Deputy Chairman of Rajya Sabha .

Question Hour:

The first hour of every sitting is generally devoted to the asking and answering of questions. It is a period when Members exercise their right to seek information from Ministers on the floor of the House. Question Hour is also used by Members to criticise the policies and programmes of the government and to ventilate public grievances.

During the 183rd session, there was no Question Hour. During the 184th and the 185th sessions, question time was allotted for 31 and 18 days, respectively. The total number of notices received in 1998 for the starred and unstarred questions came to 16730, out of which 8515 were admitted. Out of 980 starred questions, 193 questions were orally answered by Ministers which comes to about 19.6 per cent of the total number of starred questions admitted. During the year, 2 statements were made and 8 statements were laid by Ministers concerned correcting the replies given by them in Rajya Sabha in reply to starred questions. For the short notice questions 6 notices were given by Members but none was admitted. Out of 19 notices received from Members for half-an-hour discussion, only 5 notices were admitted for discussion.

Legislation:

Out of a total of 59 sittings in 1998, the House devoted itself to the Government legislative business on 42 days and the Private Members legislative business on 5 days. There were 11 Bills, as introduced in Rajya Sabha, which were referred to the Department-related

Parliamentary Standing Committees and 4 Bills, as introduced in Lok Sabha, were referred to the Department-related Parliamentary Standing Committees functioning under the direction and control of the Chairman of Rajya Sabha. The Essential Commodities (Amendment) Bill, which was introduced in Lok Sabha, was referred to the Joint Committee of the Houses of Parliament during the the184th session. Some of the important Bills which originated in Rajya Sabha and were passed by it include the Chemical Weapons Convention Bill, the Marriage Laws (Amendment) Bill, the Indian Majority (Amendment) Bill and the Patents (Amendment) Bill.

Discussion on matters of urgent public importance:

Legislation, no doubt, is an important function of a legislature but no less important is the function of ventilation of public grievances which is performed by Rajya Sabha in an effective manner. There are procedural devices like <code>I</code> special mention<code>I</code>, <code>I</code> calling attention<code>I</code>, <code>I</code> short duration discussion<code>I</code> and <code>I</code> no-day-yet-named motion<code>I</code> available to Members to raise matters of urgent public importance on the floor of the House. During the year, Members resorted to the use of the special mention, calling attention and short duration discussion procedures to raise matters on the floor of the House. In all 189 matters of urgent public importance (special mentions) were mentioned in the House. There were 312 notices of calling attention to matters of urgent public importance received out of which the following 9 were discussed in the House:

Situation arising out of suicides committed by farmers in different parts of the country due to crop failure and their indebtedness to private money lenders and the action taken by Government in regard thereto; failure of a large number of non-banking financial institutions all over the country to return public deposits amounting to over Rs. 50,000 crores and the action taken by Government in regard thereto; steep rise in inflation and its adverse impact on the economy and the people; situation arising out of widespread violation of labour laws leading to non-payment of wages, default in the payment of provident fund dues and other statutory dues; threat of American terminator seeds to Indian agriculture; NAV of US-64 and status of other Schemes of Unit Trust of India affecting lakhs of small investors; reported decision of the Government to close down eight central public sector undertakings; alarming situation due to cracks in railway lines in different parts of the country and the resultant train accidents; and revival of sick units of Hindustan Fertilizer Corporation Ltd. and

Fertilizer Corporation of India.

During the year, 110 notices for *short duration discussion* were received out of which the following 7 were taken up in the House:

Recent nuclear tests in Pakistan; alarming deterioration in the power and water supply in the country; grave situation arising out of increase in subversive activities in the North Eastern region of the country; dismissal of the Government of Goa; functioning of WTO and participation of India in the international trade negotiations; current economic situation and its implications on various aspects of Indian economy; and sugar policy.

Details of time taken on various matters in each of the 3 sessions is given in the accompanying table.

CHAPTER 2

Preface

In this report an attempt has been made to present some interesting information about Rajya Sabha, its Committees and the Rajya Sabha Secretariat. We have only given the factual information without much analysis. The purpose of this publication is to familiarise readers with some aspects of the functioning of Rajya Sabha. There is a lot of activity which goes on behind the scenes when the House is sitting. The personnel of the Rajya Sabha Secretariat work silently without much public notice to assist Rajya Sabha deliberate meaningfully on issues before it.

I had discussed the issue of bringing out a publication of this nature with Shri S. Vijay Kumar, Joint Secretary, after seeing some of such reports published in other countries. He had further conceptualised the idea and discussed the matter with Shri N.C.Joshi, Director in the Research and Library Service and asked him to prepare the report. This report is largely based on the Annual Report (1998) of the Rajya Sabha Secretariat brought out earlier by the O&M Section comprising inputs received from different Sections of the Secretariat. However, to provide an overview of the functioning of Rajya Sabha, the Resume of the relevant sessions of Rajya Sabha, brought out by the Table Office and other relevant documents have also been consulted.

The idea behind bringing out a publication of this nature is to provide information in a nutshell on the performance of Rajya Sabha and its Secretariat during the year 1998.

I hope Members of Parliament as well as the general readers would find this publication interesting. Suggestions for improvement are most welcome.
