# RECRUITMENT AND CONDITIONS OF SERVICE ORDER (No. 1 of 2018)

Subject: Methods of Recruitment and Eligibility Conditions for Appointment to the posts of Secretary, Additional Secretary and Joint Secretary in the Rajya Sabha Secretariat.

In exercise of the powers conferred by sub-rule (2) of Rule 4 and Rule 5 of the Rajya Sabha Secretariat (Recruitment and Conditions of Service) Rules, 1957, the Chairman, Rajya Sabha, hereby, makes the following Order in respect of the posts of Secretary, Additional Secretary and Joint Secretary in Rajya Sabha Secretariat, amending the Rajya Sabha Secretariat (Methods of Recruitment and Qualifications for Appointment) Order, 2017:-

#### 1. Short title and commencement.

- (i) This Order may be called the Rajya Sabha Secretariat (Methods of Recruitment and Qualifications for Appointment) Amendment Order, 2018.
- (ii) It shall come into force with immediate effect.

#### 2. Amendment of the Order.

(i) For Para 5 of the Rajya Sabha Secretariat (Methods of Recruitment and Qualifications for Appointment) Order, 2017, the following shall be substituted namely:-

#### "5. Appointment to posts not included in the Schedule -

- (i) Subject to the first proviso to Clause 4, appointment to post of Secretary-General shall be made by the Chairman.

  Also, the Secretary-General may make appointments of suitable persons to a post or a class of posts not included in the Schedule, with the approval of the Chairman."
- (ii) Notwithstanding the provisions contained in the Schedule, if no one is found suitable or the Chairman feels it expedient to do so, the post of Secretary/ Additional Secretary may be filled by persons of equivalent stature and experience from other sources on contract basis.

#### 3. Amendment of the Schedule.

The Schedule to the Rajya Sabha Secretariat (Methods of Recruitment and Qualifications for Appointment) Order 2017 is amended, incorporating the methods of recruitment and eligibility conditions for the posts of Secretary, Additional Secretary and Joint Secretary in Rajya Sabha Secretariat as indicated in the Schedule attached hereto and the consequential changes thereto.
