Oration Test	100	14.10.2015 (Wednesday)	11.00 AM onwards	In the Oration Test seven topics will be given to the candidates and a candidate will be required to speak ex-tempore for three minutes in English on any one topic. The objective of the test is to assess fluency, language content; style, pronunciation and accent; material content; and voice of the candidate.
Training on Simultaneous Interpretation	Nil	14.10.2015 (Wednesday)	2.30 PM onwards	Only those candidates who qualify the Oration Test will be imparted Practical Training on Simultaneous Interpretation. The candidate may bring bilingual written/printed material in Marathi and English for practice during training in Simultaneous Interpretation.
Simultaneous Interpretation Test (SIT)	100	15.10.2015 (Thursday)	AM onwards	Only those candidates who qualify the Oration Test will be allowed to appear in Simultaneous Interpretation Test. In SIT candidate is required to do the Simultaneous Interpretation of a recorded audio from Marathi to English (10 minutes).
Interview	40	15.10.2015 (Thursday)	4.00 PM onwards	Only those candidates who qualify the Simultaneous Interpretation Test will be allowed to appear in the Interview. The interview is structured to evaluate the interests, knowledge, traits, aptitude, skills etc. of the candidates with a view to assess his/her overall personality and to judge his/her suitability for the post.

In the Simultaneous Interpretation Test, the performance of the candidates will be assessed under five specific parameters as given below: -

i)	Coverage	-	30 marks
ii)	Accuracy	-	30 marks
iii)	Continuity in Interpretation	-	20 marks
iv)	Style and Diction	-	10 marks
v)	Voice, Pronunciation and Accent	-	10 marks
